**A. FOIA Request** – Mr. Lowery stated that we have not had any FOIA requests in the past month.

**B. Update on Gym renovations** – Mr. Lowery informed the school board that this past Friday we found a leak in the roof and water was coming into the gym. We sealed the holes and hope that this has cured the problems.

**C. REAP Grant** – Mr. Lowery stated that we will be receiving the REAP grant this year and we can use with Title 1, 2, or 4 funds.

**D. Update on HVAC Units** – Mr. Lowery commented that we will need to start replacing the HVAC units as they are starting to wear out. We received one quote from Ruyle and they have it at \$10,000 per unit. Mr. Lowery stated we are waiting to get a quote from another company.

**E. District Phone Bill** – Mr. Lowery informed the school board that we have not been on a plan with AT&T and he now has us on one which will save the school between \$400 - \$700 per month on our phone bill.

**F. Athletics** – Mr. Lowery stated that he may have a gentleman interested in coaching 5th/6<sup>th</sup> grade boys basketball. We are still looking for a volleyball coach though.

**G. 2018-2019 Budget Hearing reminder** – Mr. Lowery reminded everyone that the budget hearing is Tuesday, September 18<sup>th</sup> at 6:30am. They board members stated that they will be in attendance.


